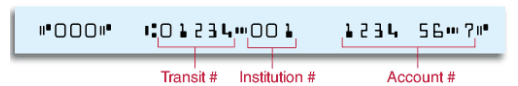
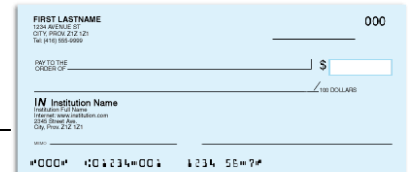

**TERMS OF SALE**

The BUYER hereby (i) requests the opening of a line of credit with the SELLER, and (ii) agrees to comply and, where applicable, cause BUYER to comply, with the following conditions:

- All invoices will be paid in lawful money of Canada at the principal place of business of the SELLER. Payment terms are **Net/30** days. All accounts which remain unpaid after 30 days will incur a monthly 1.5% interest surcharge (18% yearly) on all overdue invoices.
- There will be a \$35 fee due for each payment that is not honored by your financial institution.
- All sold and delivered goods remain the property of the SELLER until payment in full of the corresponding invoice is received by the SELLER. The BUYER will keep the goods safe, insured and provide appropriate care. The SELLER may at any time claim possession of then unpaid goods without proceedings or notice. All shipping costs shall be paid by the BUYER unless otherwise agreed to between the SELLER and the BUYER.
- The SELLER guarantees the quality of its products but cannot be held liable for any indirect or consequential damages. The claims shall be limited to the replacement of the defective product and must be filed within 10 days of delivery. The SELLER will do everything in its power to meet the delivery dates specified in the order, but it shall not be held liable for any delay in delivery of goods and services. No returns will be accepted without the SELLER's authorization.
- In the event of default by the BUYER or any alleged change in its state of solvency, the SELLER may suspend all credit, stop deliveries and any amount due will become immediately payable.
- The parties agree that this Agreement shall be construed under the laws of the Province of British Columbia.
