ATTENTION HANDLERS

Should number of entries require it, some stakes may take more than one day to complete. The Moncton Retriever Club reserves the right to change the running order, to accomodate the successful completion of the event.

RUNNING ORDER: Dogs AND Bitches will be run in the order of the draw. Rule 6.6.1c provides that "in a stake carrying championship points, a system of rotation must be implemented.." in the Open and Amateur stakes the starting order will rotate 25% of the entered field, rounded upwards, with the provision that no dog will be required to be the starter for two

series.

Rule 21.7 "It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to any indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of the regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

LISTING FEES: \$9.00 (Cdn.) per dog not registered with The Canadian Kennel Club. Every Canadian Dog must be individually registered. All foreign dogs, if not individually registered with CKC, must provide the foreign registration, pay the required listing fee and must apply for ERN number not later than 30 days after first entry in a trial.
