LISTING FEE: A listing fee of \$8.50 per dog per stake must accompany the entry of a dog for which a CKC individual registration number or ERN is not shown on the entry form.

GAME BIRDS: Ducks and pheasants may be used.

PRIZES: CKC rosettes will be awarded to all dogs who place or are awarded a C.M.

HEADQUARTERS will be located at the Tivy home.

DIRECTIONS: from HWY 17 in the village of Iron Bridge, turn north at the yellow flashing light onto HWY 546. Travel 3 kms to the Tivy's...601 HWY 546.

Testing sites will be well signed from Headquarters.

TAILGATE: there will be a free tailgate party on Thursday evening at Kevin and Linda Cheff's. A small portion of the entry fee will go towards this get together.
