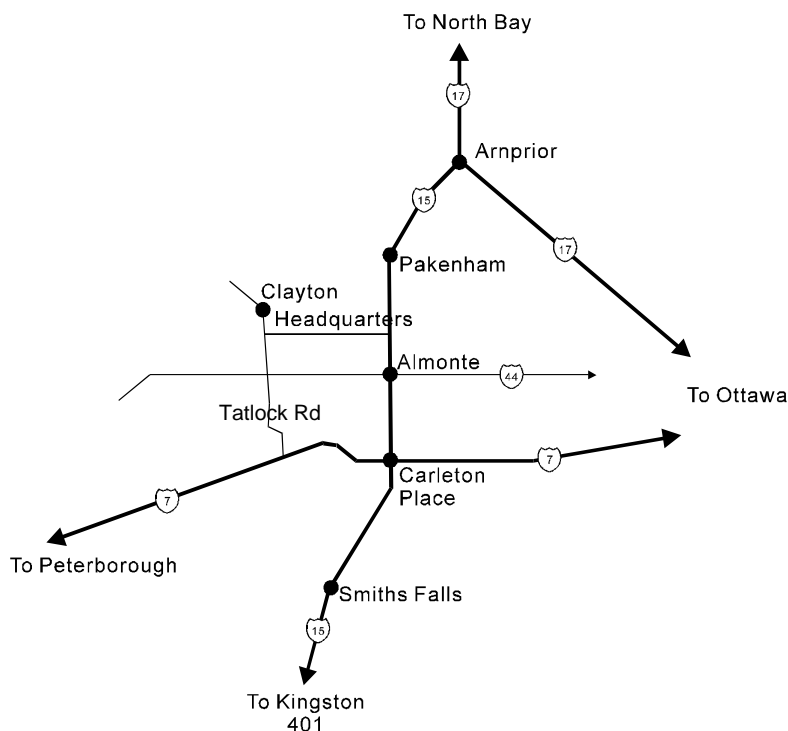

THESE EVENTS HELD UNDER THE RULES OF THE CANADIAN KENNEL CLUB

NOTE: Rule 21.7 of the Field Trial Rules states: It shall be the duty and obligation of the club holding the trial to see that a Judge, Club Official, Volunteer or any Participant at any event held under these rules is not subject to any indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the discipline committee shall have the Authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

RULE: 4.1.6 of the Field Trial Rules states: A Trial Secretary shall assume the responsibility of collecting all listing fees for the CKC, which shall be stated in the premium list.
