Entries will be accepted until the draw to be held on May 11, 2009. Attention U.S. entrants: Personal cheques must be made out for the full amount in Canadian Funds. **DO NOT WRITE 'CANADIAN FUNDS' OR 'AT PAR' ON THE CHEQUE**, as this is not acceptable at the bank and will be returned. Bank drafts or money orders must be in Canadian Funds.

A listing fee of \$8.56 (including GST) is required for dogs not registered with the CKC. CKC registration or ERN number must be applied for within 30 days of the trial or all wins and awards will be canceled. Application forms are available from the CKC at the above address.

Bitches in season may not compete and must be with drawn. Entry and listing fees paid for any dog withdrawn because of estrus, injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the F.T. Secretary before the start of the stake to qualify for a refund. All dogs will run in the order of the draw except where the mechanics of the field trial dictate otherwise. Ducks will be used at each stake.

TRIAL HEADQUARTERS AND LOCATION: The trial headquarters will be along the Shelley Rd, at the Northwood Scale house. Watch for signs posted. For further directions or information, phone Dan: (250) 962-2246.
