A listing fee as established by CKC must accompany the entry of a dog for which a CKC registration number is not shown on the entry form or ERN notice.

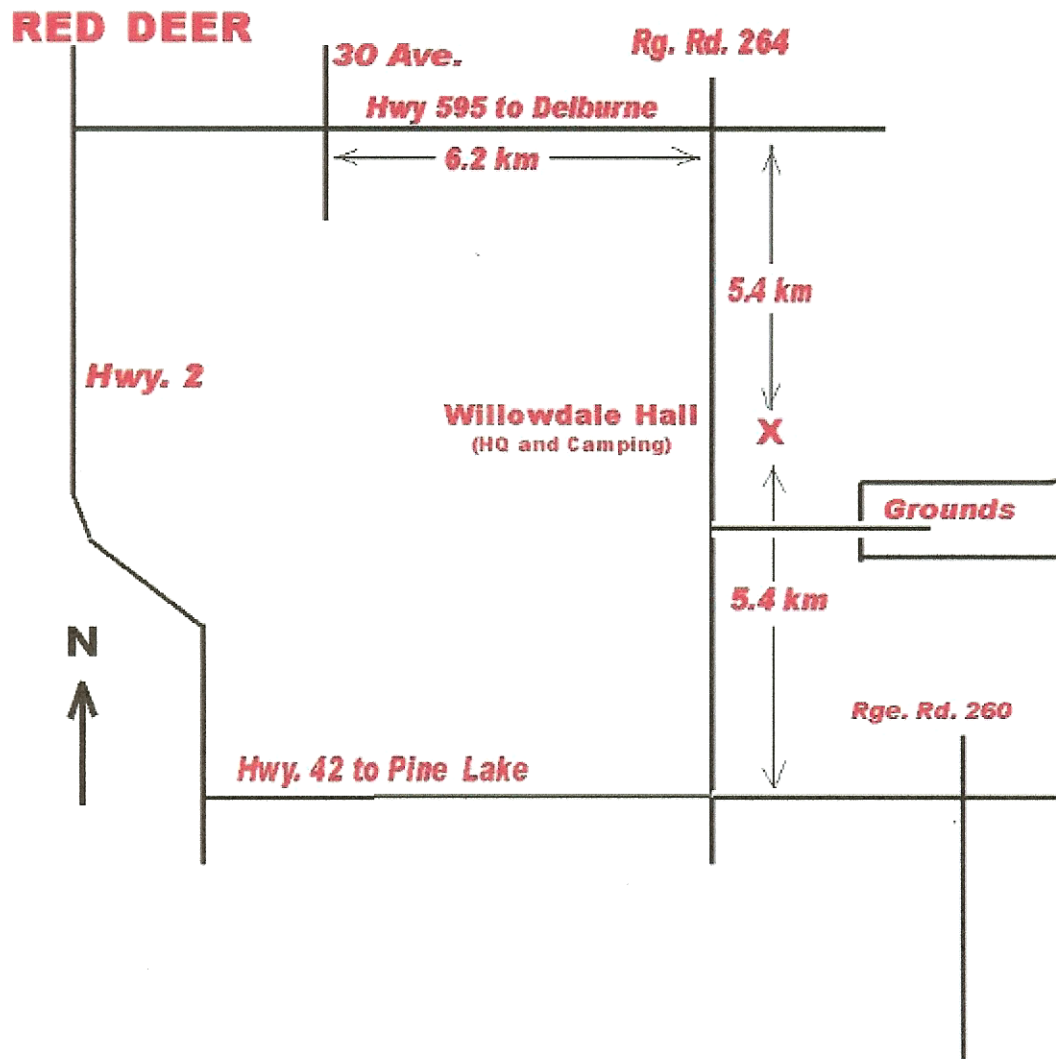
**Release and Indemnification of Landowners**
