Entries for puppies will be accepted on Saturday, a minimum of 4 puppies will be required to run this stake.

SCRATCHES: Fees, less five dollars, will be refunded (at Field Trial Committee's discretion) upon application within 14 days of the trial. Bitches in season and injured dogs will be totally refunded but a veterinary verification may be requested.

NOTE: Ducks and/or pheasants will be used in all stakes except puppy where pigeons and/or ducks will be used. **Running order in the Open will be done on a rotation basis. The TSX Closing method of selecting the starting dog in Open will be used (on June 4, 2009)**

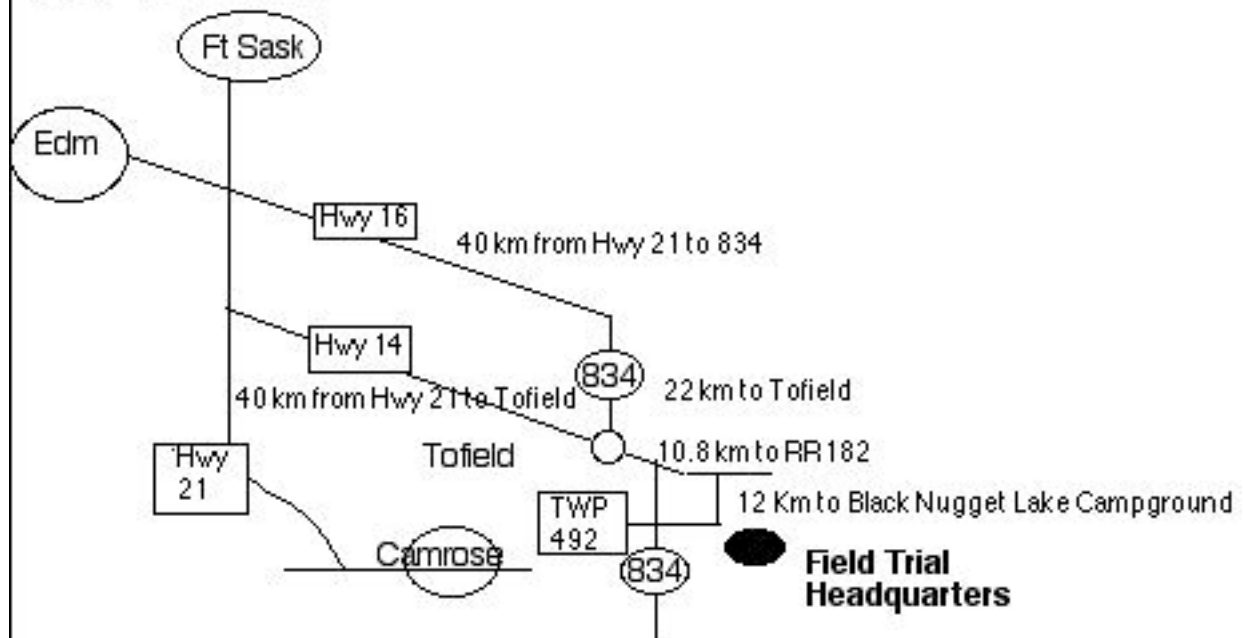
NOTICE TO COMPETITORS AND SPECTATORS
