RE: Respect for NGCL Hall and other groups using the NGCL Hall

As President of the Community League, and on behalf of the Executive, I am writing this letter to your group as a reminder that use of the Hall is a privilege and not a right. It is important, therefore, that you look after the Hall and be respectful while you are in the Hall.

As a group that uses the Hall without paying the Community League, the Executive believes that you should ensure you look after the Hall and ensure you leave it clean each time you use it for your functions. I have listed below some reminders:

1. Make sure when you enter the Hall that you check to ensure there are no damages. If you find anything that is damaged or left in disrepair, please report this to Steve Twigg (Buildings & Grounds) 455-3382, or Marg Bowler (Daytime Contact) 455-1112
2. Please refrain from running around and "rough-housing". The Hall is not a racetrack and it is dangerous to allow running in the hallways.
3. When using the washrooms, please do not litter. Leave them clean and without litter or dirty diapers. Remember to take dirty diapers with you when you leave.
4. If you spill anything on the floor or carpets, please clean it up. Cleaning supplies can be found in the kitchen (mop, pail, rags and paper towels).
5. If you break anything, please report it to Steve Twigg 454-3382 or Marg Bowler 455-1112.
6. If you use the kitchen, leave it clean and ensure you clean anything used (ie dishes, countertops, floor, etc,)
7. The dishwasher is to be used ONLY for cleaning dishes - not toys or any other objects.
8. If you need to use the Hall when another group has booked the Hall, please ensure the other group agrees.
9. If you need to change the date or time when you normally use the Hall, you must advise Jean Chernish at 455-1543. She is responsible for all Hall bookings and must know who is in the hall at all times.
10. If you have handicapped persons in your group who drive a vehicle, make sure they know if they are using the handicapped parking spots, they MUST NOT block the Hall entrance.
11. DO NOT SMOKE in the Hall or at the front entrance and respect all smoking and fire regulations.
12. Take your garbage out to the large green bin when you leave.
13. When leaving the Hall, please check that all taps are turned off, external doors are locked, the heat control is turned to "unoccupied" and all lights are turned off BEFORE you set the alarm and lock the entrance door.

The Executive appreciates your cooperation in respecting the Hall and helping the League save money by conserving the energy which we use to heat and light the Hall and the water we pay for drinking, cleaning and using the washrooms.

Members - \$100.00 + \$50.00 cleaning fee Non-members - \$150.00 + \$50.00 cleaning fee

Mini-Parks and Gardens Report: Natalia Krawetz

Parks and Gardens under NGCL Care:

- The shrub bed beside the Community League Hall.
- The raised garden in the Hall parking lot.
- The mini-park at 135 St and 107 A Avenue.
- The mini-park at 135 St. and 110A Avenue.
- The mini-park at 107 A Avenue and 133 Street.

All have had some work done on them (weeding, pruning, and/or planting).

Work on 107A Avenue and 133 Street is on-hold at present. On May 30 some person(s) sawed all the branches off all the mature spruce trees in that park, from the ground level to a distance of about 12 feet, left the debris strewn about (including on top of shrubs) and some half-cut branches hanging. Bill MacDonald and I delivered flyers (May 31 st) to the 31 residents adjacent to this part asking for witnesses to contact the police and asking that residents not go into the park because it was dangerous to do so. As a result I spent a very unpleasant weekend fielding phone calls. Residents are divided with some being stunned that such damage could occur and some rejoicing because of improved visibility in spotting vehicular traffic. I sent several voice- and e-mails to our neighbourhood constable but have yet to hear from her; and I had detailed discussions with John Dudka from the City Parks Department. Until Mr. Dudka determines what is best for this park, all volunteer action is suspended. The Forestry part of the City came to assess the damage and deal with the debris (largely cleared now).

As a result of discussions with John Dudka I learned several new (to me) rules about our work in Partners in Parks. These rules are not specified in the agreement I had signed. [A copy of this agreement form is in the NGCL Office files (second drawer - Buildings and Grounds, under Mini-Parks).]

Partners in Parks tee-shirts have arrived and are in the process of being distributed to volunteers, with the understanding that those working on League beds will put a small amount of time into City beds in order to 'merit' wearing the tee-shirts. Because of resident confusion with who is or is not supposed to be working in these parks/gardens, I have asked all volunteers to wear their shirts when they are 'on duty' •

. I have issued revised guideline to all volunteers based on my understanding of the new (to me) rules from the City. These guidelines have been reviewed and approved by Mr. Dudka.

I have asked that our work with mini-parks and gardens be put on the September Executive Committee Meeting Agenda so that the League can discuss its role over the long-term. At that time, Bill and I will consider our term as mini-parks and gardens coordinators completed and will not be continuing in that capacity.

NGCL Family Programs Report June 17, 2008

Playschool

Playschool wrapped up last week. A new executive team has been put together and will start now as the 2007-08 school term is done. Maki agreed to be president for another year. Currently, we have a full class of 16 registered for next year and we will only be running one class, 3 times per week just as we have this year. Our current teacher, Amie, will teach next year. There is concern that supplies have been removed from the playschool room by other groups using the room (assumed to be accidental) but it would be good to have this communicated to other users, as the playschool must replace the goods from their own monies. In addition, the Playschool executive would like to know if it is possible to have the telephone system set up with mailboxes so there can be an official phone number for the school with the hall. Indoor Playground & Babysitting Cooperative

N.G.I.P. finished running on Mondays as of May 26, and will continue on Wednesdays until the end of September, except where day camps or painting of the hall requires otherwise. The toy clean-up on May 26 and Year End Party May 28 were well attended, and there is great anticipation for the summer months. The executive is very excited about trying out Thursdays from 2:30-4:30 starting in October. The Babysitting Co-op continues to operate with five participating families.

Ride to Survive and Four Wheel Drive

These programs were run on May 24 with full enrolment. The weather cooperated and the participants all learned about bicycle safety including keeping their bikes well tuned, wearing helmets properly and proper hand signals. These two groups were able to do their lessons on the splash-pad and so the parking lot was not needed or blocked off.

Father's Day Bar-B-Que

Melissa Steinke organized the **Father's Day Bar-B-Que**. The date for the bar-b-que was Jun 14, 2008 from 4:00-7:00 p.m. This was run in conjunction with the Soccer Wrap-Up Party. There will be a more complete report from this event at the next NGCL Exec meeting.

Safe at Home

This program promotes safety around the house for children between the ages of 6-12. Unfortunately there was not enough enrolment for the city to run it (they need at least half of the full enrolment and only had 1 registration).

Front Porch Program

The Front Porch "know your neighbour" program continues to run through to September 7. A wrap up Pancake breakfast is planned for September 6 in conjunction with Community Day. Please mark the following dates on your calendar and plan to get acquainted with your neighbours: July 6, August 3 and September 7.

Summer Programs

Soccer Stars - soccer program in July

Fun, non-competitive soccer skills sessions for children. Skills include basics of ball control, passing and shooting. No program on Fridays. Cost is \$10 per registration. See ereg.edmonton.ca for dates, times and registration.

Green Shack

The STEP application for funding of the eight week program (plus one week training) has been approved, and Jen Myroon has worked tirelessly to ensure that we have financial coverage to run this program. Between the STEP grant, NGCL's contribution and the City Top UP dollars, we will be able to cover the pay of our Green Shack staff.

Publicity Update – *submitted by Donna Jackson*

1. May newsletter was printed and delivered on time and posted in the hall on May 27th.

May newsletter complaint - 1 complaint received about my “Rule of Thumb” if walking dogs through our park – Lady did not appreciate us allowing any dogs in our Park and had called by-law to check it out. I explained we were forced to remove our “NO DOGS ALLOWED” signs several years ago by the City when they redefined what “PARKLAND” was. This has been an on-going issue over the years and the Executive took a stance a couple of years ago that we are not opposed to dogs “passing through our park” as long as they are on leash and stay on the paved paths. This encourages more traffic through our park in the summer – in hopes of discouraging undesirables who damage our property. We do not support dogs being in the playground sand, running loose on the fields or on the cement area of the park and this is enforceable by the by-law that states dogs must be kept at least 10 meters from playground, sports field or picnic sites.
